### What is the MoU Airbus-NAG?

The purpose of the Memorandum of Understanding (MoU) between Airbus and the NAG is to establish a long-term strategic relationship in the field of sustainable aviation research and innovation, for both academic and industrial parties.





### What is a scouting session?

- The goal of the scouting sessions is to identify opportunities for Dutch companies and institutes by connecting them to relevant Airbus experts on specific topics.
- Scouting session comprise of two digital meetings:
  - 1. Airbus presents its challenges related to the topic. This is a plenary meeting with Airbus and all organisations.
  - 2. The organisations pitch their technology or service. For each organisation a dedicated time slot will be reserved.

#### Leading sustainable aviation - Cabin ambition

Transparence


- Provide transparency on environmental impact of the cabin parts and operations
- Support Airbus decarbonisation journey by reduced CO<sub>2</sub> emission cabin options and more efficient cabin operations
- Establish a framework for cabin end-of-life management and first solutions



- Introduce new cabin interior solutions and materials with low CO<sub>2</sub> impact and enhanced customer guidance
- Reduce significantly cabin products' waste during production and landfill at end-of-use
- Establish new end-of-life management approaches



- Integrate the next generation cabin in a hydrogen-powered aircraft and support the reduction target of 46% greenhouse gas emissions intensity
- Ensure a recoverable cabin **zero landfill & incineration** of cabin materials at end-of-use (except if required by regulation)
- Establish a **circular cabin** based on the elimination of waste and pollution as well as circulation of products and materials


